2010 SCHOLARSHIP APPLICATION

Deer Run Retreat is a 501(c)3 non-profit organization; and because we are not part of a larger agency, scholarships are provided through donations. The number of scholarships awarded each year are based on the amount of contributions received by donors.

Due to the generosity of these donors, Deer Run Retreat is able to provide need-based scholarships to families with very limited personal/family financial resources and who would like to give their children a summer camp experience or who would like to attend a weekend event at Deer Run Retreat, such as the Married Couples Weekend or the Father-Son Adventure Weekend.

To be considered for scholarship funds, please mail (**do not fax**) the following to Deer Run Retreat, 3845 Perkins Rd, Thompson's Station, TN 37179. Note: All information received is maintained confidentially.

To be considered, all information must be complete.

- scholarship application (2 pages)
- copy of 2009 tax return (1040 or 1040A or 1040EZ)

NOTE: Camp scholarship applications are reviewed the first week of May and applicants are contacted by mid May approval to receive full or partial scholarship funds. If approved, you will be given instructions about the camper registration process and due date for any funds you are responsible for paying.

Scholarships are awarded based on:

- financial need,
- potential for personal growth and development,
- space availability, and
- scholarship funds available.

In order to allow as many families as possible to enjoy Deer Run Christian Camps or a Deer Run Retreat weekend event experience, **scholarships are only allowed for a maximum of 3 family members for summer camp sessions and/or one weekend event per year.** More families can be awarded scholarships if you are able to pay a portion of the camp or event fee. Reduced rates and scholarship dollars **do not apply** to bus transportation or extended care for camps.

We want to be able to continue to provide financial assistance to families in the future and would appreciate a letter from you reflecting what the experience has meant to your camper(s) or to your family after the camper's experience or your family's weekend experience. Our donors enjoy knowing that their contributions have made a difference in the lives of others. A carefully written letter will also ensure your camper or your family first consideration for financial assistance next year.
